**Driving Directions:**

**From I-35 South:** Take Exit 256B to Lake Avenue, go to second stop light along Frontage Road. Take a right and follow signs to stay on Lake Avenue. Turn right on Buchanan Street at stoplight.

**From Hwy 61 / I-35 North:** Take Exit 256B off of I-35, make a left and follow signs to stay on Lake Avenue. Turn right onto Buchanan Street at stoplight.

**From Iron Range / Hwy 53:** Turn right onto Mesaba Avenue from Central Entrance. Turn left on 7th Street at the stop light. Go one block and take a right onto Lake Avenue. After crossing over the highway overpass in the Canal Park district, follow signs to continue on Lake Avenue. Turn right at Buchanan Street at stoplight.

**MPCA Parking:**

Enter lot at Buchanan Street. Inside the lot, Paulucci Building is the last one on the left. There is a \$2.00 fee charge for this lot Memorial Day through Labor Day. There is free parking on the street.
