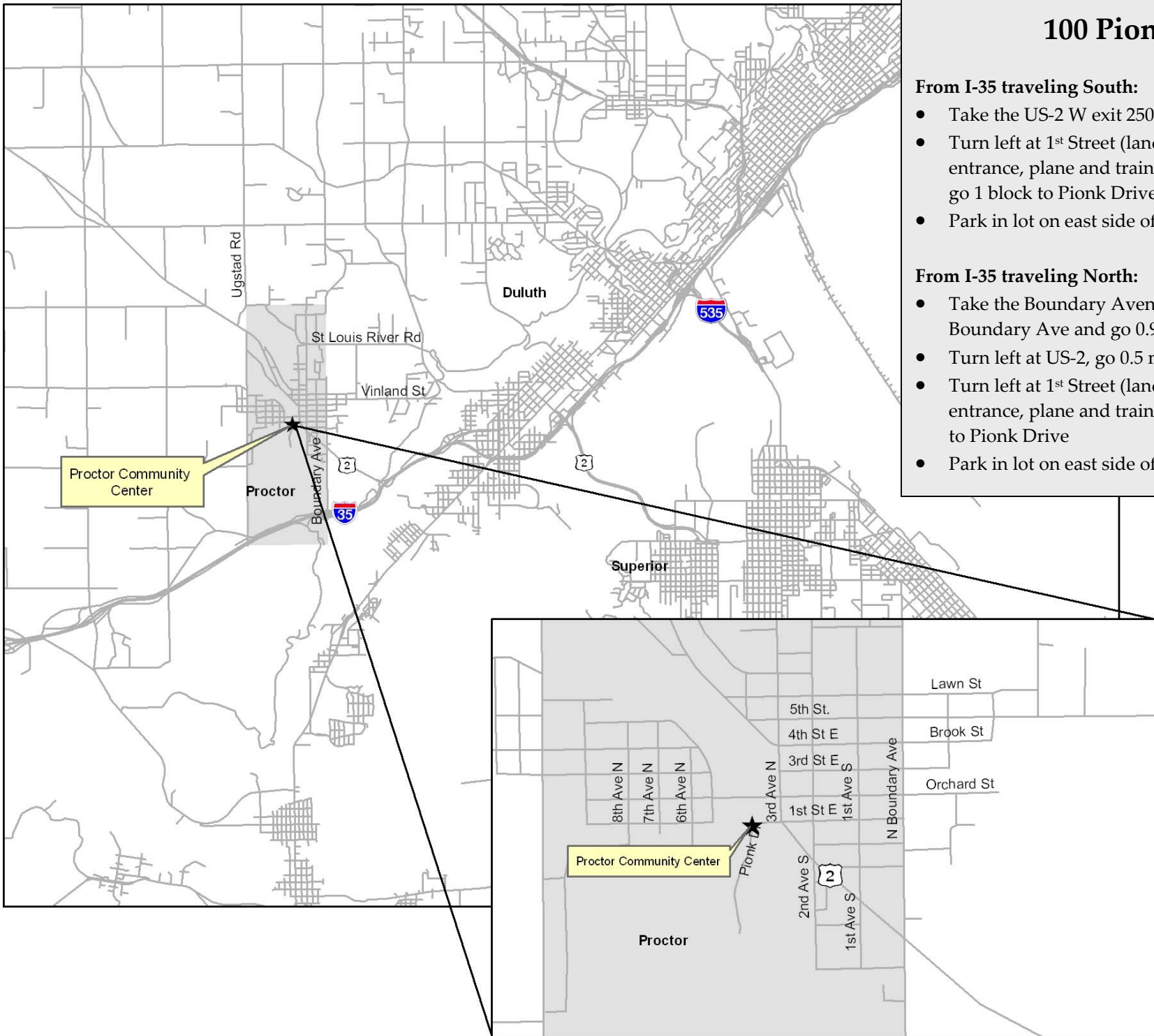
Proctor Community Center 100 Pionk Drive

- Turn left at US-2, go 0.5 mi
- Turn left at 1st Street (landmarks: just past golf course entrance, plane and train display on left); go 1 block to Pionk Drive
- Park in lot on east side of building
